1.0 BACKGROUND

Zambia’s natural resource base is under immense pressure from various development sectors, including mining, energy, infrastructure and agriculture. Some of the main drivers of deforestation emanate from these sectors. The mechanism for reducing deforestation and forest degradation (REDD+) presents an opportunity for Zambia to address deforestation in a comprehensive and integrated manner by involving identified sectors and key actors. As such, Zambia developed the National REDD+ Strategy focusing on tackling different drivers of deforestation in both the forestry and other identified key sectors in particular, agriculture, energy, mining and infrastructure. The Vision of this Strategy is to contribute to a prosperous climate change resilient economy by 2030, anchored upon sustainable management and utilization of the nation’s natural resources towards improved livelihoods.

The Project now invites suitably qualified TSPs including private sector and Non-Governmental Organizations (NGOs) to lead the implementation of activities as described under the scope of activities in project priority landscapes in the Eastern Province. TSPs can express interests as individual entities or as a consortium to deliver on the scope of this consultancy in its entirety in either of one or both landscapes in Eastern Province.

2.0 OBJECTIVE

The TSPs will support/facilitate planning and implementation of integrated land use and resource management that meet the climate resilience/mitigation and livelihoods objectives of rural households in the Eastern Province for the selected landscapes. This will assist in meeting ZIFLP’s goal of investing in low carbon development initiatives that include district level integrated land use planning, participatory community land use planning, sustainable forest management, climate smart agriculture (CSA) and value chain development that address the underlying causes of deforestation and forest degradation.

3.0 SCOPE OF WORK

The broad set of activities to be supported by TSPs will include value chain development in the wildlife sector.

The TSPs will assist communities with preparation business plans and applications for sub grants through the ZIFLP to support the above livelihood activities, and support implementation of livelihoods activities to completion, including supervision of sub grants.

The TSPs are expected to manage the community sub-grant cycle including all Environmental and Social Safeguard requirements in collaboration with the District Multi-sectoral Teams, the ZIFLP-ESIO, and the relevant government agencies and departments.

4.0 Specific area of TSPs engagement will be in the *Development of Sustainable Wildlife Management Initiatives*. ZIFLP seeks to promote practices which will maximize opportunities for rural communities that live adjacent to the Lukusuzi and Luambe National Parks and the surrounding Game Management Areas. Selected activities should all lead to measurable improvement in biodiversity conservation. The project has begun the process of developing Community Resource Boards in Chinunda and Zumwanda GMAs but would like to extend to the remaining areas. Support to CRBs will be for priority sustainable wildlife management activities, including eco-tourism.

5.0 SELECTION CRITERIA

Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services these include:

- (i) The TSP must show evidence of successful implementation of an integrated landscape, development, conservation or climate resilience project that utilized innovative tools and strategies to achieve both conservation and rural livelihood outcomes in the last five (5) years.
- (ii) A minimum of 10 years demonstrated experience of working with rural communities and forest-dependent communities in Zambia on community-based projects in sustainable land and resource management with demonstrated results
- (iii) Understanding and experience of REDD+ and GHG mitigation in landscape management would be highly desirable
- (iv) Experience of working with other national or international NGO/private sector led value chain, aggregation models, enhancement of market linkages and conservation centered livelihood development is a requirement.
- (v) Experience of working in the Eastern Province is desirable

Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers (January 2011 revised July 1, 2014), setting forth the World Bank's policy on conflict of interest.
